Use your member profile to access members-only resources

If you are accessing your profile for the first time, go to www.afccnet.org:

- ◆ Click “Login” on the right side of the homepage.
- ◆ Click “Reset password.”
- ◆ Enter your email address and a temporary password will be emailed to you.

To log in to your profile:

- ◆ Click “Login” on the right side of the homepage.
- ◆ Enter your email address.
- ◆ Enter your password.
- ◆ Click “YourProfile” under the “Membership Center” tab.

Here, you can fill in any missing information, update privacy settings and change your password.
